CURRICULAR REPORT FROM GRADUATE COUNCIL TO FACULTY SENATE

At its Meeting No. 75 on October 23, 1970, the Graduate Council considered and approved (where necessary) the following curricular matters which are now submitted to the Faculty Senate for information or confirmation as indicated.

No matters of information were presented to the Graduate Council at this meeting.

- II. Matters Requiring Confirmation by the Faculty Senate.
 - A. College of Arts & Sciences
 1. Department of Geography

Request that the Master of Marine Affairs Program be administered through the Department of Geography. This request has the approval of the Provost for Marine Affairs and of the interdepartmental Administering Committee for the program. The reasons for the change are to facilitate and render more effective the administration of the program, to provide a departmental home for appointments in "Marine Affairs", and to give such appointees representation within the Faculty. The Marine Affairs program would form an autonomous unit within the Department of Geography and its operational budget (from Sea Grant) would be administered through the College of Arts & Sciences.

- B. College of Resource Development
 - 1. Department of Resource Economics
 - a. Add (New)

Resource Economics 450: Resource Policy and the Environment II, 3 crs.

A detailed examination of the economic aspects of current resource policy problems. Economic effects of recent changes in public attitudes, legislation, agencies and functions are analyzed, current research and its role in decision-making is examined. (Lec. 3) Prerequisite: Permission of Department. Staff.
