No information pertaining to conditions of physical or emotional health or matters of past civil or criminal records shall be deemed as relevant criteria for denial of admission. Information of this kind shall not be required on the application form. However, the applicant may volunteer such information as he or she believes would be beneficial for the Admissions Office to have. If the Administration considers it necessary to have such information, it should be obtained after completion of the admissions process.
