BILL #70-71 - 13

No member of the staff or faculty of this University who holds the rank of Assistant Professor, its equivalent or higher shall become a candidate for any degree at the University of Rhode Island. A member of the staff or faculty who holds the rank of Instructor, its equivalent, or lower may become a candidate for an advanced degree at the University of Rhode Island.

Degree candidates at the University of Rhode Island who hold the rank of Instructor, its equivalent, or lower should not be promoted beyond the rank of Instructor until all requirements for the advanced degree have been met at this institution or the individual relinquishes his status as a degree candidate at this university.
