Amend Section 5.75.12 of the University Manual pertaining to the composition of the Curricular Affairs Committee as follows: by deleting "or Vice President for Academic Affairs, at the option of the President" from the end of the first sentence and adding "or his designated representative". The sentence would then read, "The committee shall comprise . . . and the President or his designated representative."

The sentence would then read, "The membership shall comprise . . . and the Vice President for Academic Affairs or his designated representative."
