BILL # 70-71 - 36

Amend Section 7.61.13 of the University Manual to read as follows:

7.61.13 Upon the completion of the contractual year during which the sabbatical leave is taken, the faculty member shall begin to again accumulate leave service credit, becoming eligible for an additional sabbatical leave upon the accumulation of an additional (minimum) six-year period of service credit.
