BILL # 70-71 - 36

Amend Section 7.61.13 of the University Manual to read as follows:

7.61.13 Upon the completion of the <u>contractual</u> year during which the sabbatical leave is taken, the faculty member shall begin to again accumulate leave service credit, becoming eligible for an additional sabbatical leave upon the accumulation of <u>an</u> additional (minimum) six-year period of service credit.
