TITLE: Credit for Pass/Fail at other institutions.

BILL #70-71 - 37

Add the following to Section 8.46.17 (page 68) of the University Manual:

If this "other institution" has only a "Pass-Fail" grade system or the equivalent, then their pass grade shall be interpreted as a U.R.I. "S" and their Fail shall be treated as a U.R.I. "U" in calculating the student's cumulative record.

Section 8.46.17 would then read:

8.46.17 A regular University student who registers with the approval of the academic dean, in courses at another institution shall have all the grades and credits included in his cumulative record in the same manner as though the courses were taken at the University. If this "other institution" has only a "Pass-Fail" grade system or the equivalent, then their pass grade shall be interpreted as a U.R.I. "S" and their Fail shall be treated as a U.R.I. "U" in calculating the student's cumulative record.
