 Development of Spanish thought particularly with respect to sociological and cultural problems from the eighteenth century to the contemporary period as seen through the writings of significant essayists. (Lec 3) Prerequisite: graduate status or permission of instructor. In alternate years, next offered 1972-73. Hutton.
- SPA 592 Religious Sources of Hispanic Literature II,3 Significance of religion in Iberian culture and its reflection in major literary works. (Lec 3) Prerequisite: graduate status or permission of instructor. In alternate years, next offered 1971-72. Hutton.
- SPA 462 Contemporary Spanish Writers II, 3
 Spain as seen through the works of major contemporary figures beginning with Garcia Lorca and the Generation of 1927. (Lec 3) Prerequisite: one of the following, SPA 325, 326, 407, 408 or permission of the instructor. In alternate years, next offered 1972-73. Freedman.
