PSY 691 Individual Practicum in Teaching Psychology I or II, 3 Seminar and supervised experience in the teaching of psychology primarily at the undergraduate level. Students will be involved in laboratory and discussion groups under supervision. (Lec 3) May be repeated up to two times. Prerequisite: permission of the department. Camp, Staff

PSY 692, 693 Directed Readings and Research Problems I or II, 3-6 each Directed readings and advanced research work under the supervision of a member of the staff arranged to suit the individual requirements of the students. Prerequisite: Permission of department. Staff
