On September 11, 1975, the Faculty Senate adopted the following changes in the procedures for evaluating administrators as recommended by the Executive Committee:

That the following changes in the procedures for Evaluating Administrators be approved:

- a) That the Ad Hoc Faculty Senate Evaluation Coordinating Committee and the College Evaluation Committees be given the authority to transcribe comments written on the evaluation forms in order to maintain the confidentiality of individuals participating in the evaluation. The original comments will not be forwarded to anyone and will be destroyed by the committee.
- b) That all evaluations conducted by the Ad Hoc Faculty Senate Evaluation Coordinating Committee and the various College Evaluation Committees be completed by November 1, 1975.
