On November 20, 1975 the Faculty Senate approved the following motion:

That the Faculty Senate endorse the plans for an intersession between Fall, 1975 and Spring, 1976, prepared by the students, faculty members who are willing to participate and administrators, with the understanding that this will not constitute a precedent for establishing an intersession, a precedent for uncompensated intersession teaching or a precedent for tuitionfree credits.
