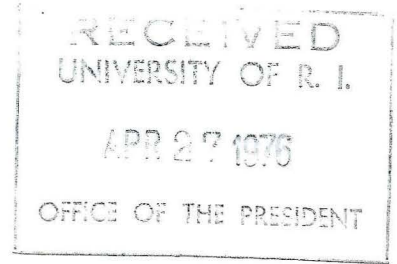

FACULTY SENATE

On April 22, 1976, the Faculty Senate approved the following charge to the Library Committee proposed by the Constitution, By-Laws and University Manual Committee:

5.84.10 The Library Committee. This committee shall act as liaison between the University Library and the faculty as a whole and advise the Library on matters of general faculty concern; consult with the Library Faculty on long-range needs of the Library and the adequacy of budget provisions to meet those needs; report annually to the Faculty Senate and propose Senate action relating to the University Library.
