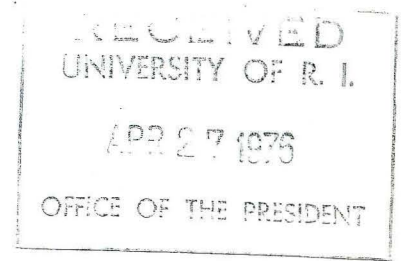

is forwarded for your consideration.

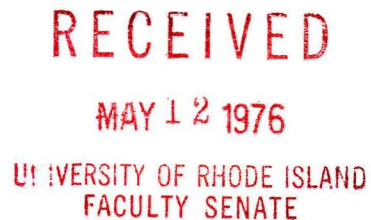
2. The original and two copies for your use are included.

FACULTY SENATE

On April 22, 1976, the Faculty Senate approved the following recommendation of the University College and General Education Committee:

That there be included in the University's General Education requirements the following new selection to be effective September, 1976:

- a) Computer Science 220 (division C) and all other courses in Computer Science (division B).
