Curricular Matters Submitted to the Faculty Senate for Confirmation:
College of Home Economics

Department of Child Development and Family Relations

CDF 250 Gerontology: Theory and Application I and II,3 Introduction to the study of aging processes: Biological, psychological, and social theories. Health, social and other age related problems will be examined in the classroom and through field experience. (Lec. 2, Rec. 1) Spence and Staff

- 10. Students participating in the Intersession Program shall be assessed fees in accordance with the fee schedule published by the Office of the Dean of the Summer Session.
- 2. Senator Wenisch intends to propose the following amendments to the report:
  - a. In line 4 of introductory paragraph, after the word "established," insert "by means of negotiations between the AAUP and the Regents"
    - rationale: This amendment clarifies the intention of the committee.
  - b. In the last line of the introductory paragraph, delete the period after semester and insert "and provided that the tuition and fees question is resolved satisfactorily." Delete provision #10 of the report.
    - rationale: This amendment is called for because the establishment of tuition is the responsibility of the Board of Regents.

If amendments a and b are both approved, the introductory paragraph would read as follows (changes are underlined):

The Ad Hoc Committee on Intersession recommends that the University of Rhode Island establish a formal Intersession Program with courses offered for credit as well as non-credit courses, provided that a mechanism for faculty remuneration is established by means of negotiations between the AAUP and the Regents and provided that the academic calendar as approved by the Faculty Senate explicitly provides for an intersession program period between the end of the Fall semester and the beginning of the Spring semester and provided that the tuition question is resolved satisfactorily.

c. In provision 5, delete "subject to the approval of the Curricular Affairs Committee" and insert "governed by all regulations affecting temporary courses with the exception that they may be offered more than twice and that the offering is not limited to a two year period."

rationale: This amendment clarifies the committee's intention and makes it explicit that the committee intends to create a new category of courses.

If amendment c is approved, provision #5 would read as follows (change is underlined):

5. Credit courses to be offered as part of the Intersession Program shall be known as Intersession courses and shall be governed by regulations affecting temporary courses with the exception that they may be offered more than twice and that the offering is not limited to a two year period.
