University Manual Section 5.73.11 charges the Academic Standards and Calendar Committee with reviewing "any proposed change in the approved calendar prior to its adoption by the Senate." Further, according to an opinion provided by the Constitution, By-Laws and University Manual Committee, "...any academic program offered during the Intersession period constitutes a calendar change..." (See, Letter from Prof. R. Gutchen to Prof. J. Kowalski, dated Dec. 11, 1975, reprinted in Faculty Senate Minutes #7 --75-12-11, pp. 1-2).

In order that it discharge its responsibilities and in order that it not hinder a program which may be authorized, the Academic Standards and Calendar Committee brings forward the recommendation below.

RECOMMENDATION:

The Academic Standards and Calendar Committee recommends approval of the following:

That, conditional upon approval by the appropriate authorities of an "Intersession Program" between the Fall and the Spring Semesters of the 1976-1977 Academic Year, the Academic Calendar for 1976-1977 be modified by designating Monday, January 3, 1977, the first day and Friday, January 14, 1977 the last day of the Intersession Program period.
