Annual Report of the Faculty Senate R.O.T.C. Affaris Committee 1977-1978 Academic Year

The Faculty Senate R.O.T.C. Affairs Committee met twice during this academic year. At an organizational meeting held on October 19, 1976, the committee met with Lt. Col. McKeon to review the current R.O.T.C. program and enrollment.

All classes are above minimums and enlargement this year of the freshmen and sophomores indicate future growth of enrollments.

The committee discussed with Lt. Col. McKeon the proposed revisions of General Education Requirements and the possible impact on the R.O.T.C. program. The Military Science Department had submitted four courses for General Education consideration. It was decided that the committee did not need to take any action until the General Education and/or Faculty Senate made some decisions on these courses. If for some reason the R.O.T.C. courses were not accepted for General Education credit, the 1977-78 Committee could then study the impact on the R.O.T.C. program and suggest some action.

On Friday, January 28, the chairwoman and the Faculty Center program committee sponsored a Happy Hour to honor the R.O.T.C. faculty and give members of the University community an opportunity to ask questions about the program. The Happy Hour was well attended.

The second meeting was held during February. No problems were perceived as requiring further committee action. The situation did not change during the spring semester and the committee, therefore, brings no recommendations for legislation before the Faculty Senate.
