Disadvantages-

^{1.} In most years the fall semester is significantly shorter than the spring semester (1-1.5 weeks).

In years when Labor Day is late, the fall semester has as few as 13 weeks of classes.

^{3.} Due to the fall holidays, it is not possible in some years to have an equal number of class meetings for each day of the week. This forces classes and labs which meet once a week to lose an additional entire week of work.

on March 24, 1977, The Academic Standards and Calendar Committee, responding to the criticisms and discontent of some faculty members over the current academic calendars, proposed modifying the 1977-1978 calendar by holding semester exams immediately after Christmas. Though individual senators expressed concern over the calendar, the Committee's recommendation found little support. Instead, the report was returned to committee with instructions: 1) to consult with officers of the Student Senate and G.S.A.; 2) to seek clarification of the faculty vote for semesters of equal length; 3) to come back to the Senate with alternate proposals; 4) to consider proposing a calendar with two full weeks of classes after Christmas; 5) to consider more than one year's calendar; and 6) to consider a quarter system. (See, Minutes, Faculty Senate Meeting, March 24, 1977.) No deadline for return was given, but the Committee deliberated over calendars and is now submitting its report.

Attached are four different calendar options - each worked out for the five year period 1978-1983. Option A is the calendar as it would look if we follow current practice. Option B is a modification of the current calendar which ensures four-teen full weeks of instruction in the fall semesters by requiring up to three days of Saturday classes in certain years and by holding registration before Labor Day each year. Option C is a calendar which compensates for the current shortage of classroom hours by lengthening class meetings to a full sixty minutes. Option D is a traditional semester calendar requiring two full weeks of classes in addition to final examinations after Christmas. Certain advantages and disadvantages of each type of calendar as well as data showing the total number of classes for each day of the week for each semester can be found listed on the sheets.

The Committee is not itself recommending any one of these options but is merely presenting them. Unless one of them or some other alternative is proposed and adopted, the University Calendar will remain as established by Senate legislation of April 10, 1975. That legislation fixes the calendar along present lines until June, 1980.
