MINUTES

Faculty Senate Executive Committee Meeting #7 - September 27, 1978

- The meeting was called to order at 10:00 a.m. in the Faculty Senate Office, Chairperson Donnelly presiding. All members were present.
- The Minutes of Executive Committee Meeting #6, September 20, 1978 were approved as corrected.
- 3. The Agenda for Faculty Senate Meeting #3, October 12, 1978/was reviewed.
- 4. Chairperson Donnelly gave a report of the Alumni Association Executive Committee meeting on September 21, 1978. The Executive Committee asked Chairperson Donnelly to write a letter to the Alumni Association Executive Committee informing them that the Faculty Senate Executive Committee feels that it wants to have the option of appointing a representative to the Alumni Association Executive Committee from the entire Faculty Senate membership rather than having the selection restricted, as the Alumni Association had requested, to someone from the Faculty Senate Executive Committee itself.

5. The Executive Committee discussed a memorandum from Dr. Richard Polidoro requesting that the Gerontology Program be transferred to the College of Human Science and Services. Following discussion, the Executive Committee asked Chairperson Donnelly to forward the proposal to the curricular Affairs Committee with a request that the CAC review the proposal and make a recommendation to the Faculty Senate as soon as possible.

 The Executive Committee decided that an election should be held to replace Professor Thompson on the University College and General Education Committee for the remainder of the Fall Semester 1978.

- The Executive Committee scheduled a discussion for its meeting on October 11 of the proposed University Fellowship Committee.
- 8. The Executive Committee decided to arrange a meeting with the Graduate Student Association Executive Committee and the Student Senate Executive Committee. The purpose of the meeting would be to exchange ideas on matters of common interest to the three groups.
- 9. Professors Haas and Rogers met with the Executive Committee to discuss the procedures being followed in the review of University College. Professor Haas announced that he expected to submit his report to tice President Ferrante in mid-October.

The meeting was adjourned at 11:40.

C. College of Arts and Sciences and Graduate Library School 1. Cooperative Program

The Department of History and the Graduate Library School propose a cooperative program by which students could earn simultaneously the degrees of Master of Art and Master of Library Science. Recognizing the value both for professional development and for enhancement of potential for job placement, the Committee on Cooperative Programs recommends that the Graduate Library School and the History Department enter into a cooperative program by which students could earn simultaneously the degrees of Master of Arts in History and Master of Library Science.

Program: Since the recent action by the GLS reduced the number of credits required for the MLS to 30 for students enrolled in the double Masters' program (27 taken in GLS, 3 in an outside elective), the joint program would be 30 credits for each degree. In practice, this would mean that the student would take a minimum of 54 credits, according to one of the following patterns:

> (1) 24 credits in History, with six credits in Library Science accepted for elective credit in the History program on transfer from the 27 credits required by the GLS in Library Science, plus 3 credits outside elective in some field acceptable to GLS.

> (2) 27 credits in History, with 3 credits from LS program accepted on transfer to the History program as elective credit, and 27 credits in LS, with 3 credits in History accepted as outside elective credit in the MLS program.

(3) 27 credits in Library Science, with 3 credits in an outside elective acceptable to both GLS and History, and 24 credits in History, with the 30 credits for the MA in History made up by transfer of 3 credits in LS and the 3 credits in outside electives from the MLS program.

It is believed that students will benefit the most if they enroll in both programs at the same time, maintaining a balance in their courses in History and Library Science so far as actual offerings make this possible. Such concurrent enrollment will provide needed flexibility in programming as not all courses are given every semester or even every year. In recognition of the needs of part-time students, however, it was indicated in the discussion before the Graduate Council on September 22, 1978, that an overall time limit of seven years would be applied to students who were concurrently enrolled in both programs.

One course concerning the aging individual (CDF 504: Developmental Issues of Later Life). A second course focusing on biophysiological aspects of aging (to be developed) or on the organization of society vis-a-vis aging (SOC 438: Aging in Society). A third course to be taken within the student's participating degree program bringing to bear the skills or knowledge of that discipline to the issues of aging. Each student would meet a research or practicum requirement consistent with departmental expectations (minimum of six credit hours) and participate in a common practicum seminar. (Supervision for the research or field experience would be the responsibility of the participating departments. The seminar leadership would be provided by the Program in Gerontology).
