FACULTY SENATE

On October 12, 1978, the Faculty Senate voted to approve the following recommendation of the ROTC Affairs Committee which was first introduced on April 27, 1978:

That the ROTC Affairs Committee be disbanded at the end of the academic year (1977-78) and that section 4.45 of the By-Laws of the Faculty Senate be deleted.
