FACULTY SENATE

On December 7, 1978, the Faculty Senate approved the following amended version of section <u>9.13.10</u> of the <u>University Manual</u>, recommended by the Constitution, By-Laws and University Manual Committee in its Report #78-79-1:

<u>9.13.10</u> Political Groups. Politically-minded student groups, both partisan and non-partisan, may be recognized by the University and may hold meetings for business and discussion in rooms in University buildings, but these groups shall not use campus facilities free of charge for meetings or rallies open to the general public which are intended to promote the campaigns of candidates for public office.
