FACULTY SENATE

On April 10, 1980, the Faculty Senate approved the following amended charge to the Faculty Welfare Committee recommended by the Executive Committee:

4.30 The Faculty Welfare Committee. This committee shall make recommendations regarding requests for lease extensions to the Graduate/Faculty Housing Office, review annually University Manual provisions that relate to matters of the collective bargaining agreement and propose changes to keep these provisions consonant with the latest collective bargaining agreements and consider such other non academic matters, except salary and compensation received in the form of financial benefits, as may be suggested by the committee itself, the General Faculty, the Faculty Senate or the University administration.
