#### FACULTY SENATE

On April 10, 1980, the Faculty Senate approved the following recommendation of the Constitution By-Laws and University Manual Committee:

That the Faculty Senate approve the following new section 11 to the By-Laws of the Faculty Senate and the renumbering of present section 11 as section 12:

### Section 11. Budget Reports to the Senate

- 11.1 In September of each year, the President shall present a State of the Budget address to the Senate. The address shall include a statement of the President's priorities for the University for the year. At the same time, a two and three year budget statement shall be published jointly by the President and the Vice President for Business and Finance.
- 11.2 Each May, the Vice President for Business and Finance shall report to the Senate on the newly constructed operating budget for the upcoming fiscal year. In January, the Vice President shall present to the Senate a summary report concerning expenditures at the six month point in the current budget cycle. If, in the judgment of the Executive Committee, significant changes subsequently develop, an additional presentation shall be scheduled.
