University of Rhode Island Faculty Senate Academic Standards and Calendar Committee Report #79-80-5

BACKGROUND:

In 1978 the Faculty Senate passed legislation fixing the Academic Calendars for the years 1978-79 through 1982-83. (See F.S. Minutes, #11-78-3-9) However, over the past several years, a number of concerns have been voiced by students, faculty, and/or staff about the planned Spring Semester calendars. One is over the long uninterrupted stretch of classes from the beginning of the semester until Spring Recess which occurs in some semesters. The other is that reading days are usually scheduled on Saturdays and Sundays instead of on week-days.

In response to these concerns, the Faculty Senate, in February, 1979, approved a recommendation to modify the planned Spring 1980 Calendar by adding a holiday around Washington's Birthday and by scheduling reading days on week-days instead of week-ends. (These recommendations would have been followed had not events made other changes desirable.) This year the Academic Standards and Calendar Committee is making similar recommendations for the Spring 1981 Calendar.

RECOMMENDATION:

The Academic Standards and Calendar Committee recommends that the existing Spring Semester calendar for 1980-81 be replaced with the calendar proposed on the following pages and that similar actions be taken with Regard to calendars for 1981-82 and 1982-83.

Faculty Senate Executive Committee Meeting #37 - April 14, 1980

- The meeting was called to order at 8:30 a.m. in the Faculty Senate Office, Chairperson Swonger presiding. All members were present except Senator McNab.
- The Minutes of Executive Committee Meeting #36, April 7, 1980, were approved, albeit begrudgingly.
- The Agenda for Faculty Senate Meeting #14s, April 24, 1980 was reviewed and its final form approved.
- The Executive Committee reviewed the Agenda for Faculty Senate Meeting #14, April 27, 1980.

Copies of an Addendum to Agenda #14 which listed all of the items under <u>Un-</u> <u>finished Business</u> were distributed to members of the Executive Committee.

- The Executive Committee discussed the names of possible faculty members to serve as nominees for Ombudsman.
- 6. The Ombudsman's Report (Fall, 1978 through Fall, 1979) and Chairperson Swonger's April 11 memorandum to the Academic Standards and Calendar Committee requesting a review of recommendations raised by the Ombudsman were distributed. The Executive Committee discussed the recommendations outlined by Chairperson Swonger in his memorandum.
- 7. Vice Chairperson Swan reported on the annual meeting between the Regents and Legislature which had been held on April 8, 1980.
- Vice Chairperson Swan reported on the April 11 meeting of the Interinstitutional Committee on Articulation Transfer. She stated that the document being drafted by the committee on the transferability of courses between the institutions would be available shortly.
- The Executive Committee agreed to the following topics for their April 21 meeting with President Newman, Vice President Ferrante and Assistant Vice President Pezzullo:
 - a. Ombudsman's Report;
 - b. Status of Quattrocchi Bill;
 - c. Status of Revens Bill providing Private School Tuition Subsidy.

The meeting was adjourned at 9:35 a.m.
