FACULTY SENATE

On September 11, 1980, the Faculty Senate approved the following recommendation of the Executive Committee:

That section 8.21.12 (formerly 8.40.13) of the University Manual be deleted effective Fall, 1981 in light of the Senate's approval of the new general education program on May 22, 1980.
