

At its meetings of October 6, November 3 and November 10, 1980 the Faculty Senate Curricular Affairs Committee considered the following matters now submitted to the Faculty Senate.

Informational Changes (Including Temporary Courses)

- A. College of Arts and Sciences
 - 1. Department of History
 - a. HIS 302X Introduction to Ancient Greek History and Culture (SS,3) The Greek world through study of history and archaeology, of literature, and archaeological sites, comparison of art and architectural styles to their function in society. This course will be taught in Greece.

 Pre: Special application to the Summer Session Office by March 18, 1981. Daniel
 - b. HIS 303X Later Greek Culture-Its Legacy Unto Christian Times (SS,3) Later Greek Culture, the Hellenistic Age, Roman and Christian eras in Greece, examination of archaeological styles from Classical to Christian. This course will be taught in Greece. Pre: Special application to Summer Session Office by March 18, 1981.

Classics

CLA 398X Culture of the Ancient Romans (SS,3) Culture of ancient Rome through literature and archaeology. Attention given to art and architecture, religion, private and public life. Includes field-trip to Rome, Pompeli, other sites.

- d) PHL 342 Knowledge, Belief and Truth (1 or 11,3) Analysis of topics such as knowledge, belief, certainty, doubt, scepticism, faith, the ethics of belief, truth, error, perception, apriori knowledge, subjectivity and objectivity, and memory. (Lec. 3) Pre: 3 credits in philosophy or permission of instructor. Hanke, Peterson, Schwarz

MINUTES

Faculty Senate Executive Committee Meeting #14 - November 18, 1980

- The meeting was called to order at 11:00 a.m. in the Faculty Senate Office, Chairperson Swonger presiding. All members were present except Senators Wenisch and West.
- 2. The Minutes of Executive Committee Meeting #13, November 5, 1980 were approved.
- The meeting with Vice President Ferrante on his Plan for Rebalancing the Colleges was discussed briefly.
- 4. The Executive Committee agreed to the following topics for their November 25 meeting with President Newman, Vice President Ferrante and Assistant Vice President Ferrante and Assistant Vice President Pezzullo:
 - a. Library staffing;

b. Proposed Conference on Proficiency Testing;

- c. Publication of the University's 2 and 3 year budget statement which was to be circulated in conjunction with the President's State of the Budget Address:
- d. The status of the University's paper supporting its request for an additional 1.1 million dollars;
- The change in Budget Policy adopted by the Board of Regents on November 13.

5. Report on Matters Before the Regents

Chairperson Swonger reported on an action taken by the Board of Regents for Education at its meeting on Thursday, November 13, 1980. The action was a change in the Regents' policy regarding fiscal control of the post-secondary institutions and provides that "the Board shall allocate specific amounts in each post-secondary budget for personnel costs, utilities, out-of-state travel, repairs, capital and scholarships, as well as the overall budget allocation." The action provided further that the institutions must seek prospective authorization for any increase or decrease in allocations to the above categories.

The Executive Committee discussed at length the apparent motivation for this change in policy, the implications inherent in the selection of the particular budgetary components singled out for specific allocation control, the implications for management of the University, and the Journal Bulletin editorial reaction to the change in policy.

It was agreed that every effort should be made to focus the attention of the University Community and the Faculty Senate in particular on the significance of this major change in policy.

 Following discussion, the Executive Committee agreed to recommend to the Faculty Senate that no further action be taken on Senate Bill #80-81--4 which had been disapproved by the President.

- 7. Vice Chairperson Swan reported that Professor Malina had suggested that the faculty Senate create an ad hoc committee to work in support of the educational bond issue when it is next proposed. It was agreed that implementation of Professor Malina's suggestion should be considered by the Executive Committee the next time an educational bond issue was on the state ballot.
- 8. Senator Swift reported that Senator Malik had suggested that the Senate employ a group of outside consultants to review the impact of budget crisis on our academic programs. It was agreed that the proposed review by outside consultants might be a useful undertaking if the Senate had any discretionary funds to use for such a purpose.

Chairperson Swonger reported that he had already suggested to Professor Krausse that the Teaching Effectiveness and Facilities Committee study how the budget problems at the University has affected the academic quality of our programs.

- Chairperson Swonger announced that Professor Katula was scheduled to report to the Senate on the activities of the Athletics Advisory Board on December 4.
- In response to a request from Professor Towers, the Executive Committee discussed possible areas which hight be explored by the Budget Advisory Committee during 1980-81.

The meeting was adjourned at 12:17 p.m.

C. The Curricular Affairs Committee has adopted the following policy statement regarding proposals to abolish programs:

The Curricular Affairs Committee recognizes that proposals to abolish academic programs have academic quality and resource aspects in addition to those of state and regional needs. When a recommendation for program elimination or curtailment is routed directly to the CAC from the Vice President for Academic Affairs or the appropriate Dean or College Faculty the following guidelines shall apply: Where no reasons for abolition are presented to the CAC which relate to the lack of academic quality of the program, either with regard to standards uniquely pertinent to the program

or with regard to the quality of the program relative to all programs at the University, the CAC must disapprove the abolition of the program. Where reasons are presented for abolition related to the lack of academic quality of a program, the CAC will balance the academic value of the program with the resources saved and/or the resources necessary to raise the academic quality of the program, and approve or disapprove the abolition of the program accordingly. In all cases, the decision by the CAC will be facilitated by the opinion with regard to academic quality of the pertinent college faculty and college curriculum committee. When a recommendation for program elimination is forwarded from the Program Review Committee, the CAC shall review the recommendation in consultation with a member of the Program Review Committee, express its opinions, and forward the recommendations and opinions to the Faculty Senate within three months.

SECTION 11

Curricular Matters Which Require Confirmation by the Faculty Senate

- A. College of Arts and Sciences
 - 1. Department of Art

CHANGE: Curriculum for Bachelor of Fine Arts:

Bachelor of Fine Arts

It is recommended that students intending to enter the B.F.A. program in art plan to complete ART 120 in the freshman year and to have completed an additional 3 credits in art history and a minimum of 24 credits in studio by the end of the sophomore year.

Students in the B.F.A. program must complete a minimum of 72 credits in art. Studio courses required of all majors include: ART 101 (3), 103 (3), 207 (3), 208 (3), 403 (3), 404 (3), 405 (3), and 406 (3).

An additional 15 credits must be selected from 200 level studio courses, and an additional 15 credits must be selected from 300 level studio courses.

ART 120 is required of all students and an additional 9 credits must be selected in art history, 3 credits of which must be numbered 300 or above.

An additional 6 credits of art electives must be selected at the 300 level or above in either studio or art history.

A minimum of 126 credits is required for graduation, distributed as follows: distribution requirements (45), major requirements in studio (54), art history (12), studio and/or art history electives (6), and electives (9).

French

ADD: FRN 208 Preparation for Study in France (11,3)
Required of students participating in Orleans
Exchange Program. Emphasis on listening comprehension and oral expression through class discussion, visiting lecturers and language laboratory. Restricted to students participating in Orleans Exchange Program. Pre: 205 or equivalent and permission of instructor. Not open to freshmen. Hyland

Hebrew

ADD HBW 101, 102 Beginning Hebrew (1 or 11,3) Fundamentals of grammar and pronunciation; exercises in reading, writing and conversation. (Lec. 3) Pre: 101 for 102. Jagolinzer

- 3. Department of Music
 - a. ADD: The following courses:
 - 1) MUS 209 Jazz Improvisation II (11,3) Intensive study and performance of improvisation in jazz music with attention to blues, ballad, jazz-rock, Latin jazz, and Free jazz styles. (Lec. 1, Lab. 4) Pre: 208 or permission of instructor. Staff
 - MUS 307 Composing and Arranging for Jazz Ensemble II (11,3) Advanced linear and voicing techniques. Arranging and orchestrating standard and original material for small and large ensembles, with intensive score analysis. Pre: 304. Crook
 - b. CHANGE: Level and number for MUS 218 to "MUS 306 (218)."
 - c. CHANGE: Description of Jazz Concentration by deleting "MUS 218 (3) and 421* (3)" and adding "MUS 208* (3), 209 (3), 306 (3), 307 (3)."
- B. College of Human Science and Services

Department of Physical Education, Health and Recreation

ADD: The following courses:

- 1) PED 306 Classical Ballet-Advanced (I and II,1) Advanced level of instruction for students who have acquired intermediate skills and have performing experience in ballet (Practicum 3) Pre: 106D, 206D. Marsden
