CONSTITUTION, BY-LAWS AND UNIVERSITY MANUAL COMMITTEE REPORT #1980-81-1

In response to a request from Faculty Senate Chairperson Swonger that the CBUM Committee review $\frac{4.21}{\text{By-Laws}}$ of the By-Laws of the Faculty Senate, the CBUM Committee proposes that the $\frac{\text{By-Laws}}{\text{By-Laws}}$ be amended in order to eliminate any ambiguity.

The Constitution, By-Laws and University Manual Committee recommends that 4.21 of the By-Laws of the Faculty Senate, the charge to the Academic Standards and Calendar Committee, be amended as follows (changes are underlined):

4.21 ... In addition, this committee shall review any proposed change in the approved calendar originating outside the committee as well as any amendments attached by the Faculty Senate to a calendar proposal prior to Faculty Senate adoption of the calendar in its final form except that, if the Senate Executive Committee declares an emergency situation prior to the Faculty Senate meeting at which calendar proposals are to be considered, a calendar proposal amended on the Senate floor may be approved at the meeting during which the proposal has first been introduced.

The existing section 4.21 of the By-Laws reads as follows:

4.21 ... In addition, this committee shall review any proposed change in the approved calendar prior to its adoption by the Faculty Senate.

Changes in the By-Laws require a 2/3 majority vote and may not be voted upon at the meeting they are introduced.
