FACULTY SENATE

On February 13, 1975, the Faculty Senate approved the following new section of the <u>University Manual</u> as recommended by the Executive Committee:

5.13.12 The Senate's representatives on the Development Council shall report at least once each semester and at any time there is a major change in policy. They shall keep the Senate informed of policies in effect.
