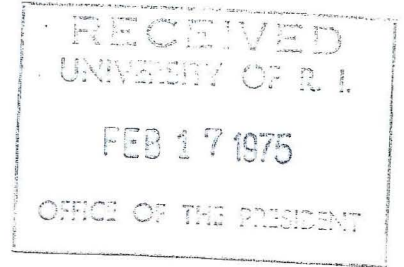

FACULTY SENATE

On February 13, 1975, the Faculty Senate approved the following recommendation of the Executive Committee:

That section 8.48.18 of the University Manual be amended by deleting the word "diploma" and inserting "permanent record." The new 8.48.18 would read:

8.48.18 Any student who has met the requirements for two separate concentrations within any single bachelor's curriculum has earned a double major and may have both fields listed on his or her permanent record.
