On March 13, 1975, the Faculty Senate approved the addition of the following new section to the University Manual as recommended by the Executive Committee:

8.55.18 A student who has selected the pass/fail option for a course may, if he or she chooses, notify the Registrar before the last date for dropping a course that he or she has decided not to use the pass/fail option.

This Manual section was based upon Recommendation #5 of the 1973-74 Report of the Ombudsman and was unanimously endorsed by the Academic Standards and Calendar Committee.
