That department chairpersons not be evaluated during the 1974-75 trial evaluation of administrators and that the Evaluation Coordinating Committee consider the appropriateness of evaluating department chairpersons and the effect of contract provisions upon possible evaluation of chairpersons and make recommendations to harmonize evaluation procedures and contract provisions.
