On April 24, 1975, the Faculty Senate approved the following recommendation of the Executive Committee:

That Deans Knauss and Youngken be evaluated as Deans, but that they not be evaluated as Provosts during the 1974-75 Evaluation of Administrators; and that the evaluation of Provosts be post-poned until the role of Provost is clarified.
