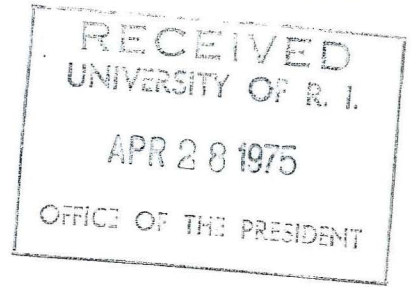

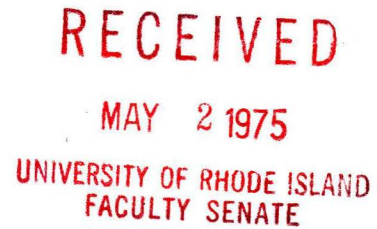

On April 24, 1975, the Faculty Senate voted to amend sections 8.47.13 and 8.47.19 of the University Manual as follows:

Changes are underlined

8.47.13 No fewer than six days, exclusive of Sunday shall be allowed for each final examination period, but eight days are recommended. Whenever possible final examinations shall be scheduled at the rate of two per day based on the cycle in which each class meets during the semester.

8.47.19 The final examination period should begin no earlier than two days after the last day of classes. These days could include a week-end. When the Calendar allows it, three days are recommended.
