## UNIVERSITY OF RHODE ISLAND Kingston, Rhode Island

On May 8, 1975, the Faculty Senate approved the addition of the following new section to the <u>University Manual</u>:

8.12.15 A student may withdraw from a course later than the announced expiration date for withdrawal with the consent of the department chairman, or in the absence of a chairman, or if the chairman is the instructor, the dean of the college if at mid-term the student has requested but received no evaluation of his or her work in the course.
