 I. Department of Music
 a. Add (New)

MUS 551 Applied Music as Minor or Elective I and II, 2 each Private instruction. One forty-minute lesson and scheduled practice hours each week. One level, one year, as prescribed in applied minor syllabi. (Studio 6) Prerequisite: Completion of applied minor in undergraduate upper division and permission of the department. See under Music 251 for areas of instruction. Staff

b. Change

MUS 451 to 454 Applied Music as Minor or Elective change to read: MUS 451 Applied Music as Minor or Elective I and II, 2 each Upper division. Private instruction. One forty-minute lesson and scheduled practice hours each week. Two levels, one per year as prescribed in applied minor syllabi. (Studio 6). Prerequisite: Completion of applied minor lower division and permission of the department. See under Music 251 for areas of instruction. Staff

Comment: At the present officers of the Naval War College write two term papersone for GEG 591-592 and the other for MAF 650 usually on related subjects. If this request is approved GEG 591-592 will be dropped and one major term paper required for MAF 650. It will allow the officer to concentrate his efforts on a single term paper with a consequent improvement in quality and to take an additional six credits of elective courses.
