8.43.13 of the University Manual:

8.43.13 After the approval at the department level, a copy of the title, subtitle and course description for an open-ended course shall be sent to the College Curriculum Committee via the academic dean, with an information copy to the Curricular Affairs Committee, and if a graduate level course, to the Graduate Council.
