At its meeting of May 6, 1974 and May 13, 1974, the Faculty Senate Curricular Affairs Committee considered the following matters now submitted to the Faculty Senate.

CHANGE: Title for BOT 417 to BOT 417 Field Aquatic Plant Ecology.

2. Department of Geology

CHANGE: Description and prerequisite for GEL 465:

GEL 465 Introduction to Geophysics

Introduction to the physical properties of the earth and the application of geophysical exploration techniques.

Seismic, gravity, magnetic and electrical field techniques and basic methods of interpretation. (Lec. 2, Lab. 3)

It is recommended that students selecting this concentration use courses in dramatic literature offered by the Department of English as partial fulfillment of Division A general education requirements. #### 2) BACHELOR OF FINE ARTS

The B.F.A. program is intended essentially for the student who plans work in M.F.A. program or study in a professional theatre school prior to seeking employment in theatre or related fields. A total of 48 credits are required as follows:

The remaining credits will be selected from the theatre catalog in consultation with the student's advisor with emphasis on the development of skills in the student's area of interest. With the advisor's consent, appropriate courses offered by other departments may be substituted or taken as supplementary to the required courses. Particularly advantageous to theatre students are courses in Anthropology, Art, Dramatic Literature, Speech, Voice, Dance, Music and Physical Education.

B.F.A. candidate are required to attend department conferences held on the average of once a month for purposes of discussing the academic program and for planning various aspects of the production program.
