This proposal, part of the procedure adopted by the Joint Educational Policy Committee for implementation of the Annual Fiscal Review, was returned to the Executive Committee with explicit instructions at the Senate meeting on April 26, 1973.

- F. Statement concerning the Charges for, and the Membership on, the Newly Authorized Special Committees on Traffic and Parking and on the Evaluation of Administrative Officers -- Vice Chairman Sink.
- G. Recommendations Concerning Further Consideration of the Master of Fine Arts in Theatre -- Vice Chairman Sink.

The Joint Educational Policy Committee voted, on May 1, 1973, "to approve in concept the Master of Fine Arts in Theatre and recommend implementation to the Faculty Senate."

The Executive Committee recommends that the Senate postpone further consideration of this program until March, 1974, when it can be reviewed in conjunction with other new programs recommended for funding by the Joint Educational Policy Committee as part of the Annual Fiscal Review.

H. Recommendation on Separation of Intercollegiate Athletic Program from the Department of Physical Education for Men and Merger of the Physical Education Departments.

The Joint Educational Policy Committee voted, on March 6, 1973, "to recommend that the Faculty Senate consider the separation of the Intercollegiate Athletic Program from the Department of Physical Education for Men and subsequently the merger of the Department of Physical Education for Men and the Department of Physical Education for Men and the Department of Physical Education for Women effective July 1, 1974.

The Executive Committee recommends that the Senate establish a special committee to study the advisability of effecting the actions that are proposed and to report to the Senate by the first meeting in November, 1973.
