Dear Maury,

I have enclosed Senate Bill Number 73-74-8, "Eighty-Second Report of the Curricular Affairs Committee." This Bill has been approved in part. I shall explain the exception. Item C in Section 2 on page fifteen of the report is a recommendation that the Home Economics Department be recognized as an official department within the College of Home Economics. Although this recommendation has my approval, it must be recognized that this matter must also be approved by the Subcommittee for Postsecondary Education of the Board of Regents. I shall bring this matter to them with my endorsement for their approval as soon as I can.

I also request that a correction be made in the report. The sub-heading of paragraph C, College of Pharmacy, in Section I of the report is "Department of Respiratory Therapy." I must call to the attention of the Faculty Senate and the Curricular Affairs Committee that there is no Department of Respiratory Therapy at the University. The sub-heading should probably be "Program in Respiratory Therapy." The program is administered by the faculty of the College of Pharmacy. I think it is important that this change (which may seem minor) be made in the official records of the Faculty Senate and of the Curricular Affairs Committee.

Experimental Courses:

1) ECN 180X Affluence and Survival

An introduction to the economic problems of life in a finite universe. Exhaustible resources, environmental decay and population pressure will be among the problems studied. Current controversies about economic growth, survival and the quality of life will be considered.

RTH 471 - Chemistry and Manufacture of Compressed Gases 2 cr.

The history, manufacture, storage, control, and clinical application of gases employed in respiratory therapy will be considered. A special reference will be made to safety considerations in the handling of compressed gases. Gagliardi

RTH 472 - Medical Electronics

A review of electricity, development of simple circuits, the use of gas electrodes, photoelectric cells, pressure and flow transducers and recording devices in the evaluation and monitoring of patients will be presented.

RTH 473 - Clinical Bacteriology

The fundamentals in bacteriology will be reviewed. This will be followed by a consideration of the dangers to patients by contaminated therapeutic devices, the importance of proper care of apparatus and the role of antibiotics in the care of patients.

RTH 474 - Introduction to Patient

Considerations will be directed to the patients outlook toward his illness, to the hospital environment in general and to the intensive care unit in particular.

RTH 475 - Respiration

Beginning with a review of basic anatomic and physiological considerations of gas movement and transfer in airways, lungs and blood, the course continues with a presentation of alteration in disease states and the role of artificial ventilation and other forms of therapy.

RTH 476 - Techniques of Respiratory Therapy

This course will cover a thorough understanding of the mechanism and application of the many techniques employed in respiratory therapy. It will encompass the wide range from a simple flow meter to pressure-volumetime and electrically controlled ventilators. Instruction in the administration by and maintenance of artificial ventilators will be stressed. Other considerations will range from simple patient comfort to advanced forms of physical therapy.

RTH 477 - Pulmonary Function

A detailed presentation will be made and experience developed in the use of apparatus to measure the patient's ability to ventilate himself. The use of spirometry, the evaluation of pulmonary mechanics, the physical diffusion of gases and principles of ventilation perfusion in healthy people as well as in patients with pulmonary disease will be presented. There will be ample opportunity for the student to enter actively into this phase of study.

RTH 478 - Organization of Respiratory Therapy Service 3 cr.

A detailed consideration of physical and management requirements for hospital and institutional services in respiratory therapy will be presented. Staff

RTH 479 - Pathologic Physiology

The effect of disease of vital process as circulation, central nervous and genito-urinary systems will be presented in general, and ventilatory processes in particular will be reviewed in detail, with emphasis on the therapeutic value of ventilatory care and reversal of disease process.

RTH 480 - Patient Care

The interrelationship of the patient with the respiratory therapist, physician, nurses, physiotherapist, and other members of the clinical team will be presented.

This entire aspect will be direct patient contact. It will give the student an opportunity to apply the knowledge and techniques previously presented to him. Every student will be individually supervised by a tutor. Gagliardi

FACULTY SENATE

The Constitution, By-Laws and University Manual Committee has submitted the following proposed amendment to section 4.14 of the By-Laws of the Faculty Senate for consideration by the Senate at its meeting of December 13, 1973.

Final action cannot be taken on an amendment to the By-Laws during the meeting at which it is introduced.

I. Rationale:

This proposal allows the Executive Committee to meet at its own choosing while maintaining the right of the faculty to receive sufficient notice of the Senate's agenda.

11. Section 4.14 of the Senate By-Laws.

A. Present Section <u>4.14.</u>

<u>4.14</u> The Executive Committee shall hold a meeting not less than 15 days before each regular meeting of the Senate to establish the agenda. It shall approve the agenda proposed by the chairman for meetings of the Senate and shall cause the agenda and relevant committee reports to be published and distributed to all members of the faculty at least one week prior to regular Senate meetings, and as early as practicable prior to special meetings.

B. Proposed Section 4.14.

<u>4.14</u> The Executive Committee shall establish an agenda in advance of each regular meeting of the Senate. The agenda and relevant committee reports shall be published and delivered to all members of the faculty at least 5 days prior to regular Senate meetings, and as early as practicable prior to special meetings.
