ENG 521X British Literature and Culture 6 credits The University of Rhode Island Department of English will offer a six-week study tour of England and Scotland, including extended stays in London, Oxford, and Edinburgh, with shorter visits to numerous other places of significance for students in British literature, history, and art. The study tour will incorporate formal lectures and discussions as well as travel, involving faculty members and other experts from local academic institutions in London and elsewhere. The department of Psychology offers doctoral programs in the following three program areas:

The program changes being recommended by the department of Psychology are mainly to allow greater flexibility so that a student and his program committee can individually tailor more of his program to the student's particular needs and interests. This is most apparent in Track 2 of the Clinical program which would have no requirements other than the minimum considered necessary for all students receiving a Ph.D. in Clinical psychology i.e. the Methodology, Research and Internship requirements.

Flexibility is increased in each of the three program areas by allowing students to choose 6 of 8 content areas rather than having to take the 6 specific core courses presently required for a Ph.D. in Psychology.

INTERIM REPORT OF THE RESEARCH POLICY AND FACILITIES COMMITTEE

Revision of Item 5 of the 1972-73 Committee Report.

- A. Intent: To provide administrative flexibility in the employment of professional personnel on noncontinuing grant or contract funds.
- Justification: Present classification of faculty positions is such that professional staff often cannot be employed on noncontinuing grant or contract funds at levels of compensation equivalent to that of regular faculty. All new faculty positions must be approved by the State Board of Regents where approval is normally restricted to teaching positions. Employing faculty on noncontinuing funds is risky because the University may become obligated to tenured positions when the funding supporting these positions is terminated. However, the stimulation and vitality to be gained by including non-teaching faculty on the staff of research programs when funding is available should not be forfeited. This difficulty can be resolved by creating the rank of research professor to include all professional appointments funded on noncontinuing fiscal resources. Research faculty shall enjoy all rights and privileges afforded regular faculty including salary, fringe benefits, promotion, but not tenure, sabbatical leave or membership in a collective bargaining unit.

The classification proposed already exists in the University Manual (7.10.10), but this appears to be the only reference to this rank. Attempts to find the names of individuals holding this title have yielded only one name. Thus, although the title already exists, we are giving it a more definitive meaning, and consequently the strong possibility of greater use.

C. Recommendation: Amend section 4.12.12 of the University Manual to read as follows (changes are underlined)
4.12.12 Temporary and Part-time appointments shall be classified according to their equivalent faculty rank for the determination of salaries and salary increases. This category includes Lecturer, Adjunct Professor,

Research Professor, Research Associate and others employed under limited programs of instruction or research.

Add a new section 4.12.15 to read as follows:
4.12.15 Research Professors shall include professional personnel associated with limited research programs such as those supported by non-continuing grant or contract funds. All research professorships shall be based on appointment by the President and shall carry all rights and privileges of salary, fringe benefits, and promotion afforded regular faculty but not tenure, sabbatical leave or representation by a collective bargaining agent.
