#### FACULTY SENATE

On Thursday, February 21, 1974, the Senate approved the following change in its By-Laws:

4.14 The Executive Committee shall establish an Agenda in advance of each regular meeting of the Senate. The Agenda shall be published and delivered to all Faculty members in accordance with By-Laws Section 3.9 at least 72 hours prior to regular Senate meetings. Agendas for special meetings shall be delivered as early as practicable.
