## MINUTES

Faculty Senate Executive Committee Meeting #26 - February 22, 1982

- The meeting was called to order at 8:30 a.m. in the Faculty Senate Office, Chairperson West presiding. All members were present.
- The Executive Committee met with President Newman, Vice President Ferrante and Assistant Vice President Swan from 8:30 to 10:00 a.m. The following matters were considered:
  - a. At the request of Senator Towers, the procedures for approval of proposed modifications in the B.G.S. program mandated by the Board were discussed.

Following discussion, it was agreed that the B.G.S. Curriculum Committee should be allowed adequate time to deliberate on the proposed changes, while at the same time, the administration would report to the Board on the University's progress in complying with its charge.

It was agreed that Assistant Vice President Swan would schedule a meeting with Chairperson West, Dean Pezzullo, the Chairperson of the B.G.S. Curriculum Committee and herslef to discuss the matter.

- b. In response to a question from Chairperson West, President Newman stated that his reallocation plan was being drafted and that he hoped it would be finished by next week. He said that a list of recommendations which require Faculty Senate action would come forward at the same time as the plan. Hopefully they would be in the hands of the Senate at the March 11 Senate Meeting when the recommendation to abolish Business Education will be on the floor.
- c. Assistant Vice President Swan distributed an article on <u>The New</u> <u>York Times Selective Guide to Colleges</u> which will appear in the March 1 issue of Newsweek.
- 3. The Minutes of Executive Committee Meeting #25, February 15, 1982 were approved.
- The Executive Committee reviewed the Agenda for Faculty Senate Meeting #10, February 25, 1982.

It was agreed that Chairperson West would remind President Newman that a discussion of the issues underlying the reallocation plan was scheduled under the President's Report at the February 25 Senate Meeting.
