SUBJECT: Faculty Senate Legislation

I have approved the following Faculty Senate bills:

- #82-83--6: Deletion of Sections 4.35 of the Faculty Senate By-Laws and Addition of New Section 5.54.12 of the University Manual.
- #82-83--8: The One Hundred and Ninetieth Report of the Curricular Affairs Committee

FACULTY SENATE

On September 23, 1982, the Faculty Senate approved the following recommendation of the Executive Committee:

Delete section 4.35 of the Faculty Senate By-Laws "The Minorities and Special Groups Committee" and add the following new section 5.54.12 of the University Manual:

5.54.12 Two of the faculty members on the Affirmative Action and Equal Opportunity Committee shall be appointed upon recommendation of the Faculty Senate. The Senate's representatives to the committee shall report to the Faculty Senate at least once each year and at any time there is a major change in policy. They shall keep the Senate informed of policies in effect.
