RESEARCH POLICY AND FACILITIES CONTITUEE REPORT ON RESEARCH ADMINISTRATION January, 1983

The URI Research Council, in an attempt to resolve the research problems and strengthen research administration, has submitted a report requesting that the University establish a Division of Sponsored Programs, headed by a Vice President for Sponsored Programs with authority over all grant administration. (See Appendix A) The University administration has submitted a counter proposal to establish the position of Associate Vice President of Research, reporting to the Vice President of Academic Affairs, without authority over grant purchasing, accounting or personnel, but with a close association with the V.P. of Business Affairs for policy formation. (See Appendix B) The Research Policy and Facilities Committee has reviewed both proposals and has endorsed the report of the URI Council for Research, with the exception that the title be broadened to include unsponsored research programs. The committee, in placing the emphasis on leadership needs, has forwarded the Council's report to the Senate urging its endorsement. In addition, the committee calls on the President, in his capacity as the ultimate academic leader of our institution, to assure the Faculty that the University community will be given the necessary leadership.

The REPOFAC urges the Faculty Senate to approve the following recommendation:

That the Faculty Senate endorse the Report of the URI Research Council to establish the position of Vice President for Research with authority over grant administration; and

That, if the position of Vice President for Research or any part of the proposal is not feasible at this time, the Faculty Senate request that the Council's report be used as a future goal and that the title of Coordinator of Research be changed to Director of Research; reporting, preferrably to the President, or to the Vice President of Academic Affairs. The responsibilities of the Director to include the following as given on page 2 paragraphs 3 and 4 of the Council's report (See Appendix A):

- a. Hork with the Vice President for Academic Affairs and the College Deans to stimulate research activity by providing research services and specialized facilities;
- b. Initiate a vigorous promotion effort to locate research opportunities in industry, the state and federal governmental agencies and private foundations;
- c/ Insure stability and growth of funded research programs while committed to high quality consistent with educational objectives of both undergraduate and graduate programs;
- Serve as an ex officio member of the Council of Deans and Graduate Council;
