#### FACULTY SENATE

On November 8, 1984, the Faculty Senate approved the following revision to the charge and membership of the Joint Educational Policy Committee (JEPC) recommended by the Executive Committee:

- 5.66.10 The Joint Educational Policy Committee (JEPC) shall advise the President and the Faculty Senate. Its reports and recommendations may be addressed to either, but shall be made available to both. The JEPC shall study and make recommendations to the President and/or the Faculty Senate regarding matters of general policies affecting the University at large.
- <u>5.66.11</u> The committee shall meet at the call of the President or on request of the Chairperson of the Faculty Senate, as often as required to accomplish its purposes, but at least once each semester. Items for the agenda shall normally come from the President, the Council of Deans, the Faculty Senate or its Executive Committee.
- 5.66.12 The membership shall comprise the President; the Vice President for Academic Affairs, the Chairperson and Vice Chairperson of the Faculty Senate and one faculty member appointed in accordance with 6.3 of the By-Laws of the Faculty Senate; the President of the Student Senate (or designated representative); the President of the Graduate Student Association (or designated representative); and any faculty members or officers of the University the President may name, not to exceed three in number. The President shall chair the committee and the Chairperson of the Faculty Senate shall serve as Vice Chairperson.
