Registration Procedures

The Academic Standards and Calendar Committee recommends that the Faculty Senate amend section B.33.11 of the University Manual to read as follows (change is underlined):

B.33.11 No course shall be added to a student's schedule after two weeks from the beginning of a semester. Courses offered by the College of Continuing Education may be added with the approval of the instructor prior to the third class meeting or by the prescribed University deadline, whichever is greater.

Rationale: This minor change simply assures that instructors approval/disapproval is required in CCE courses where scheduling conditions lead a student to request an add as many as 20 days after a course has begun. Such a request, if it is prior to the third class meeting would in fact come after only 2 weeks of course work. In such cases instructors should decide the appropriateness of the add.

Pre: 100 and 212. Limited to NRS majors. Prior approval of department required. May be repeated for a maximum of 6 credits. S/U credit. Staff

3. Department of Plant Science

a. ADD: The following courses:

- 1) PLS 201 Survey of Landscape Architecture (1,3) Introduction to landscape design theory and composition as an applied art form. (Lec. 3) Hanson
- 2) PLS 202 Origins of Landscape Development (11,3) Examines the impact of environment, social history, philosophy, art and literature on architecture and landscape development from ancient to modern times. Emphasis on European Renaissance through Contemporary United States (Lec. 3) Hanson

b. DELETE: The following courses:

- 1) PLS 200 Introduction to Landscape Architecture (1,3)
