FACULTY SENATE

On January 23, 1986, the Faculty Senate approved the following amendment to section 8.57.10 of the University Manual recommended in the Academic Standards and Calendar Committee Report #85-86-1 and revised editorially:

8.57.10 Dean's List. Undergraduate students who have achieved certain levels of academic excellence shall be honored by inclusion of their names on the "Dean's List." Each semester, the Registrar will publish lists of students who have attained the required quality point average. A student may qualify for the Dean's List by completing a running accumulation of twelve or more credits for letter grades and by achieving a 3.3 quality point average.
