FACULTY SENATE

On February 13, 1986, the Faculty Senate approved the addition of the following new section 10.45.11 of the University Manual recommended by the Research Policy and Facilities Committee on November 21, 1985:

10.45.11 Copyrights. Notwithstanding any language contained in 10.40.10 - 10.45.10 to the contrary, the copyright of all text-books and scholarly works, including those of pictorial art and music, but excluding computer software other than that produced outside the line of University duty and on the creator's/creators' own time and without the use of University facilities, shall be the property of the creator(s). Works specifically commissioned by or through the University, however, will not be covered by this section but shall be subject to the applicable provisions of 10.40.10 - 10.45.10.

This section replaces sections 10.51.10 and 10.51.11.
