FACULTY SENATE

On February 5, 1987, the Faculty Senate approved the following amended recommendation of the Academic Standards and Calendar Committee in Academic Standards and Calendar Committee Report #86-87-2:

8.22.50 Commencement. Students who are to receive degrees may participate in the general University commencement ceremony. Students who have satisfied all degree requirements may participate in the individual college ceremonies. Colleges may permit students to participate in the college ceremonies if students are likely to fulfill degree requirements by the end of the summer. Exception is granted to those students due to complete their baccalaureates in Medical Technology within the month that follows commencement. Representatives of other degree programs wishing to obtain an exception may apply to the Academic Standards and Calendar Committee and the Faculty Senate.
