University Manual Sections Regarding the University Calendar

The Academic Standards and Calendar Committee recommends that the Faculty Senate approve the following revised sections 8.70.10, 8.70.11, and 8.70.20 of the University Manual (revisions underlined):

8.70.10 Preparation. In accordance with sections 8.70.20-41 the Registrar shall prepare each year's calendar and submit it to the Academic Standards and Calendar Committee for review one year prior to the beginning of the previous October.

8.70.11 The Academic Standards and Calendar Committee shall submit the proposed calendar to the Faculty Senate at the Senate's first meeting in December.

8.70.20 The Academic Year. The beginning and ending dates of each semester shall be the same for all colleges and schools of the University. Exceptions may be granted to the College of Continuing Education. Requests for exceptions shall be received by the Academic Standards and Calendar Committee no later than one year prior to October 1 of the preceding academic year.

Rationale: Currently, the University Calendar is considered by the Academic Standards and Calendar Committee in October and November of the year preceding implementation and is usually approved by the Faculty Senate in December or January. The Registrar reports that his office receives many requests for next year's calendar from faculty, administrative offices, and agencies outside the University during the fall semester, and must respond to these requests with tentative information. In addition, because this committee has so little time to recommend a calendar to the Faculty Senate, we are unable to do any kind of study or research and, as the result, often recommend a virtual carbon copy of the previous year's calendar.

The 200-level colloquium ("Media Myths: Growing Up, Growing Older") was coordinated by Professors Linda Levin (Journalism) and Don Spence (Gerontology). Pollnac (Anthropology), N. Potter (English), E. Schoonover (English). In all during 1986/87, Honors instruction was provided by 31 faculty from 19 departments and seven colleges.

B. Selection of courses and Faculty for 1987/88

For 1987/88 the committee continued the second year of its two-year experimental system for selecting faculty to teach 100 and 300-level Honors courses. The committee encouraged outstanding undergraduate teachers who wished to be designated Honors Faculty Fellows to apply to their deans for nomination. The committee selected Fellows from the nominees. Fellows committed themselves to designing and teaching one or two courses in the Honors Program. Fellows are awarded summer fellowships for instructional design and curricular innovation, attend special workshops on teaching academically talented students, and receive an Honors Fellows Key in recognition of their service.

The Honors Faculty Fellows system for selecting, preparing and rewarding an Honors Faculty is the subject of an article which appears in the winter issue of the National Collegiate Honors Council Report along with a second article on an innovative Honors course designed by URI Honors Faculty Fellow Frank Heppner. Members of the committee hope the Fellows system continues to generate interest in the Honors Program among faculty and students and brings the University additional public recognition as a higher educational institution which promotes effective teaching and exciting learning.
