CURRICULAR REPORT FROM THE GRADUATE COUNCIL TO THE FACULTY SENATE - Report No. 1987-88-2

At its Meeting No. 260 held October 23, 1987 the Graduate Council considered and approved the following curricular matters which are now submitted to the Faculty Senate for confirmation as indicated.

I. Matters Requiring Confirmation by the Faculty Senate.

A. College of Pharmacy

1. Department of Pharmacology and Toxicology

a. Changes in M.S. Program Requirements to read-

Thesis; mathematics (141 or equivalent), one course in statistics; PCL 441 and 442; BCP 581 and 582; PCL 521 and 522, and two advanced pharmacology courses.

b. Changes in Ph.D. Admission Requirements to read-

GRE and bachelor's or master's degree in pharmacy, natural science, psychology or equivalent. Students who are admitted with a bachelor's degree will be placed in the M.S. program, but will be allowed to apply for admission into the Ph.D. program after they have taken the Ph.D. qualifying examination.

c. Changes in the Ph.D. Program Requirements to read-

M.S. program requirements, with two additional advanced pharmacology courses.

B. College of Resource Development

1. Department of Community Planning and Area Development

a. Crosslisting with CVE

CPL 546 or CVE 546 Urban and Rural Transportation I,3
Issues confronting planning for urban and rural transportation systems; the variety of policies governments pursue in issues and problems; technical and political constraints, transportation studies, and demand analysis techniques. Examination of mediation, fact-finding, arbitration and other conflict resolution processes as alternatives to litigation in a variety of dispute situations; e.g. community, environmental, divorce, landlord/tenant, prison, racial, commercial, etc. (Lec 3) Pre: Permission of instructor. Staff
